ACTELLIC® controls a wide range of insect pests including those resistant to synthetic pyrethroids, organochlorines and some organophosphate compounds.

### General Pest Control Recommendations

ACTELLIC is approved for the control of cockroaches, ants, fleas, spiders, silverfish, bed bugs, flies, mosquitoes and mosquito larvae in and around domestic situations, public service areas, agricultural buildings, commercial and industrial areas and refuse tips. ### Carpets, Mats and Soft Furnishings

ACTELLIC must not be applied to carpets, mats and soft furnishings.

### Activity Against Problem Pests

ACTELLIC has proven performance against those difficult to control nuisance pests such as ants and bed bugs. The intrinsic activity of pirimiphos-methyl against these pests as well as the three-way mode of action [Contact, Ingestion and Fumigant (Vapour Phase)] provides fast knockdown, while the solvent free emulsion formulation provides excellent residual activity on a range of surfaces.

However, to ensure effective long-term control of both ants and bed bugs, all stages of these pests must be controlled and steps taken to prevent re-infestation. Integrated bed bug and ant management practices are therefore advised, involving the use of a range of insecticide types and control strategies.

### Odour Management for Indoor Use

ACTELLIC has a distinctive odour that is evident during and immediately following application. When applying the product indoors care should be taken to avoid any residual odour.

In sensitive situations the addition of de-odourisers such as Anotec\* may reduce odour persistence.

**DO NOT over-apply to beyond the point of run off.**

**DO NOT apply to carpets, mats and soft furnishings.**

**Ants:** Nests, runs, walls, drains, ant trails, windows, doors and resting places where ants are seen.

**Cockroaches:** Walls, cupboards, skirting boards, behind sinks, stoves and pipes. Pay particular attention to cracks and crevices.

**Flies:** Refuse tips, resting areas (eg. ceiling, windows, screens).

**Fleas:** Skirting, floors, kennels and adjacent wall areas.

**Spiders:** Exposed surfaces where spiders are seen, nests and known hiding places.

**Silverfish:** Walls, cupboards, cracks and crevices, ceilings and enclosed floor spaces.

**Houseflies and Mosquitoes:** All exposed surfaces where these flying insects may rest (eg. walls, ceilings, verandahs).

**Mosquito Larvae:** Unused water troughs, stagnant ponds and other mosquito breeding harbours.

**Bed Bugs:** Skirting boards, floors and adjacent wall areas. Machine wash bed linen at time of treatment to destroy bed bugs in sheets and blankets. Apply an alternative treatment to carpets and seek advice on integrated bed bug management practices.
